As previously reported on this Form 4 originally filed by the reporting person on December 12, 2007, the Compensation Committee approved on December 11, 2007 the grant of an option to the reporting person to acquire 225,000 shares of Meritage common stock. During the preparation of the option award agreement, the Company determined that this grant (1) exceeded the 2006 Incentive Plans limitation on the number of shares that may be granted to any participant during any calendar year. Thus, this 225,000 option grant is null and void, and this Form 4 is withdrawn.
